<u>MINUTES for the Mission Directorate Meeting (Video Conference) of National AYUSH</u> <u>Mission (NAM) for the year 2021-22</u>

1. The Mission Directorate Meeting (Through Video Conference) of the National AYUSH Mission (NAM) for the year 2021-22 was held on 15-12-2021 under the Chairmanship of Shri Vaidya Rajesh Kotecha, Secretary, AYUSH, to consider the Supplementary State Annual Action Plans (SAAPs) of **Uttar Pradesh & Puducherry**. List of the participants is enclosed at **Annexure-I.**

2. At the outset, Shri D.Senthil Pandiyan, Joint Secretary, AYUSH welcomed the representatives of State/UT Governments to the Mission Directorate meeting and briefed that the Supplementary State Annual Action Plan (SAAP) for the State/UT Govt. of Uttar Pradesh & Puducherry have already been appraised during the Appraisal Committee meeting and detailed observations were communicated to the States/UTs.

3. After that a brief presentation has been made by Deputy Advisor (Ayu) for each State highlighting the aspects of

- i. Year-wise Progress of expenditure and status of UCs submitted under NAM
- ii. Status of AYUSH HWCs
- iii. Status of setting up of upto 50 Bedded integrated AYUSH Hospitals
- iv. Status of New AYUSH Educational Institution.
- v. Status of approved SAAP during 2021-22.
- vi. Status of Submitted Supplementary SAAP for the year 2021-22
- vii. Status of implementation of PFMS.

ANNEXURE-II

Uttar Pradesh

Mission Directorate reviewed the Expenditure & Utilization Certificates status of the State Govt. against the previous year's grants-in-aid released to the State under the NAM scheme, Status of PFMS, Status of HWCs, Status of State Annual Action Plan, New Ayush Educational Institutions and made the following observations and recommendations:

Expenditure & Utilization Certificates

Status of Expenditure:- Under NAM, an amount of Rs. 80709.557 Lakhs (Centre Share – Rs. 49437.82 lakhs and State Share –Rs.31271.734 Lakhs) has been approved from the year 2015-16 to 2020-21. Against the releases, State Govt. has reported an expenditure of Rs.43491.252 lakhs (87.97%) against central share and Rs. 17064.523 lakhs (54.5%) against the State share. Further, it is observed that Rs.3525.418 Lakhs of State share of year 2020-21 is with the State Treasury. In this regard, State Govt. was requested to take necessary steps for the withdrawal of funds lying in the treasury.

• During the Mission Directorate meeting, it has been informed that a review meeting regarding reconciliation of UC has been conducted with Mission Director, NAM Uttar Pradesh& Staff of CPMU team on 14-12-2021 under Chairmanship of JS (DSP). As per the discussions held, State Govt. has assured that they will submit the UCs approximately for an amount of Rs 250 Crores to the Ministry. Accordingly, as per the convenience of State Govt. it was agreed that responsible officer's of State Govt. along with State PMU team may come to the Ministry at the earliest in the month of December along with all relevant supporting documents for the reconciliation of all the UCs under consultation with NAM officials including CPMU team.

Status of State Annual Action Plan- of the year 2021-22:

(i) .Mission Directorate has already approved the State Annual Action Plan for the year 2021-22 for an amount of **Rs.39325.25 Lakhs** (Central Share- Rs.23595.15Lakhs and State Share-Rs.15730.10 Lakhs). Accordingly, an amount of **Rs. 5898.7875 lakhs** has been released as 25% of the Central Share to the State Govt. of Uttar Pradesh. vide Sanction Orders No. S-16012/3/2021-NAM (Part-II) dated 08-11-2021 and same has been communicated to State Govt. vide letter No F. No. S - 16012/ 3/2021-NAM (Part -I) dated 12-11-2021 with a request to withdraw the released 25 % amount of Central share along with matching State Share from treasury to State AYUSH Society and utilize the 75% of the released amount, so that the subsequent installment of balanced approved Central Share may also be released to the State Government.

(ii). It is stated that State Government has to take immediate step regarding the transfer of released Central Share from State treasury to Single Nodal Account (SNA) at the earliest (within a period of 21 days of its receipt) and they have to also ensure that corresponding State Share should also be released as early as possible and not later than the 40 days of release of Central Share.

(iii). In this regard, State Govt. has informed that procedure of release is under process and will be utilizing the released amount and intimate the same to the Ministry regarding this at the earliest.

(iv). During the meeting, Shri. Prashant Trivedi, IAS Additional Chief Secretary, Uttar Pradesh, has also informed that due to elections, code of conduct is expected to be implemented by the end of December, accordingly it was suggested to provide formal approval for the proposed activities so that the work can be started from the allocated resource pool of SAAP.

(v) It is observed that some of the State Governments are not fulfilling the criteria of 75% of Expenditure against the previous release of Grant-in Aid. Accordingly, as per the request of

State/UT Governments who are fulfilling the criteria of 75% expenditure against the previous release of Grants, Mission Directorate considered the submitted supplementary SAAPs.

Additional Proposal of New AYUSH Education Institutions

- i. During the Mission Directorate meeting, as per the request of State Govt. in- principle approval has also been accorded by the Mission Directorate for the establishment of Ayurvedic Medical College and Hospital at Ayodhya and Homoeopathic Medical College and Hospital at Varanasi, subject to the condition that the State Govt. may furnish the relevant documents related to ownership of land, Detailed Project Report (DPR) along with the cost estimate for establishment of these colleges. Accordingly, State Govt. has furnished Detailed Project Report (DPR) ,the documents related to ownership of land and has given the commitment of creation and deployment of the required human resources for operation and running of these two hospitals vide D.O. Letter No. 465/319/M.N./2021-22 dated 22/11/2021 & D.O. Letter No. 3001/96-**3ITGN** 2-/2021 dated 30/11/2021.
- ii. The State Govt. has proposed an amount of Rs. 4983.61 lakhs for establishment of Ayurvedic Medical College and Hospital at Hunhuna- Mawai, Ayodhya and an amount

of Rs. 4988.58 lakhs for establishment of Homeopathic Medical College and Hospital at Pindra, Varanasi.

- iii. During the Mission Directorate meeting, Additional Chief Secretary, Uttar Pradesh has confirmed that amount proposed for the two new Ayush Educational Institutions is not tentative cost and have requested for formal approval, so that before the implementation of code of conduct, work can be started from the available resource pool allocated.
- iv. Mission Directorate approved the Proposal of establishment of Ayurvedic Medical College and Hospital at Hunhuna- Mawai, Ayodhya for an amount of Rs. 4983.61 lakhs and establishment of Homeopathic Medical College and Hospital at Pindra, Varanasi for an amount of Rs. 4988.58 lakhs. However, Grant-in-aid will be released subject to the fulfillment of conditionalities as issued by Department of Expenditure vide OM dated 23-03-2021.
